\*DTS (French abbreviation for Droit de tirage spécial; in English: Special Drawing Right – SDR) is an international reserve asset, created by the IMF, used as the monetary unit of the Universal Postal Union. The exchange rate valid for 2018 is as follows: 1 EUR = 0,80211 DTS.
